1) **Call to Order at 6:06.** Presented handouts and their placement into ICOC binders.

- 2) **Established a quorum** of five (5) members in attendance to begin the meeting.
- 3) **Reviewed Minutes of March 7, 2012**. Eid motioned to approve the minutes. Seconded by Beth. All approved.
- 4) There were no public comments.
- 5) ICOC Communications: Discussion of any community comments: Eid has heard many concerns about the power plant. Since the modernization is funded by the taxation of property values, he is concerned the power plant will lower the property values and Santee School District's ability to complete the Bond program. He has collected data regarding power plants. He wants to place these concerns on the next ICOC agenda as an action item. Dianne El-Hajj responded that the school board is putting it back on the agenda at the next school board meeting. Kai said that he is aware that the power plants are being built cleaner now. Why is this one any different? The City planning commission has a hearing set for the 26th of June. It can then go to the City Council.

Gina said that her son is now an eighth grader at Hill Creek. He felt that the Junior High is too crowded. He was happy to get to be in the new Junior High Building at Hill Creek prior to moving onto high school.

Jim said that the new ball fields at Chet F. Harritt have created a lot of runaway fly balls in the neighboring yards.

6) **ICOC Draft Annual Report** – Gina made a motion to accept the 2010-2011 Annual Report with the exception of changing out a couple of pictures. Kai seconded the motion. All approved.

7) **CIP Program Update Phase 2 Construction**: Handouts showed the next items which are needed to be completed for the Bond promises/school signs.

8) Comments from Committee Members

Kai asked how long we will be able to utilize Barnhart Balfour Beatty, Inc. services as a contractor. Christina responded that the District's scope of services through the Lease-leaseback award included the entire Capital Improvement Program of all nine schools and since the work isn't complete, their contract hasn't expired yet. Christina hopes that there will be another project to work on by the summer of 2013. She is waiting on the State to release additional funding and hopes to get some money by January 2013 to begin another summer program.
